- 1. Establishment of Criteria for Ranking Home Office Delivery Units (HDU) and Foreign Service Posts (FSPs)
 - 1.1 The Office Performance Commitment and Review Form (OPCRF) shall be the main tool used to assess accomplishments of the Department's HDUs and FSPs.
 - 1.2 The OPCRF shall reflect the actual accomplishments of delivery units visà-vis their work plan targets for FY 2020. Strong emphasis should be placed on an office's overall contribution to the 2017-2022 DFA Strategic Plan.
 - 1.3 Supervising offices are granted the authority to set the criteria for ranking delivery units beyond the OPCRF component. The criteria shall include a mandatory 15% allocation for administrative matters, which shall take into account the following: Budget Utilization Rate (BUR), timely submission of procurement projects to the BAC, and timely submission of mandatory reports.

The Undersecretary for Administration shall grade all the Department's delivery units on administrative matters.

 - 4.2 The OO2 offices OCA shall be rated by UCSCA, and OMWA shall be rated by UMWA.
 - 4.3 The Supervising Offices of the OO2 offices may consider rating OCA and OMWA for their extensive COVID-19 related work.

 - 6.3 The supervising offices may consider rating the concerned STO offices for their COVID-19 related work.
- 7. Process of Ranking Philippine Embassies
 - 7.1 The Embassies of the Philippine Foreign Service are the sixty-three (63) posts operating in FY 2020.
 - 7.2 They shall be rated by the Undersecretaries:
 - 7.2.1 Undersecretary for Administration (Administrative Matters)
 - 7.2.2 Undersecretary for Civilian Security and Consular Affairs (Consular Services and Overseas Voting)
 - 7.2.3 Undersecretary for Multilateral Affairs and International Economic Relations (Economic Diplomacy)
 - 7.2.4 Undersecretary for Migrant Workers Affairs (Assistance to Nationals)
 - 7.2.5 Undersecretary for Bilateral Relations and ASEAN Affairs (National Security)

- 7.4 Administrative matters shall be allocated a fixed 15% of the total grade for all Embassies. 85% of the total grade shall be distributed between National Security, Economic Diplomacy, Cultural Diplomacy and Public Diplomacy, ATN, Consular Services, and Overseas Voting. The weights given to the seven areas for each Embassy shall be subject to the approval of the supervising geographic office and of the PMT.
- 8. Process of Ranking Philippine Consulates General
 - 8.1 The Consulates General of the Philippine Foreign Service are the twentyseven (27) posts operating in FY 2020.
 - 8.2 They shall be rated by the Undersecretaries:

8.4 Administrative matters shall be allocated a fixed 15% of the total grade for all Consulates General, while 10% of the total grade shall be given by the supervising Ambassador. 75% of the total grade shall be distributed between National Security, Economic Diplomacy, Cultural Diplomacy and Public Diplomacy, ATN, Consular Services, and Overseas Voting. The weights given to the seven areas for each Consulate General shall be subject to the approval of the supervising geographic office and of the PMT.

- 9. Process of Ranking Philippine Permanent Missions
 - 9.1 The Permanent Missions of the Philippine Foreign Service are the four (4) posts operating in FY 2020.
 - 9.2 They shall be rated by the appropriate Undersecretaries, depending on issues covered by each post:
 - 9.2.1 Undersecretary for Administration (Administrative Matters)
 - 9.2.2 Undersecretary for Civilian Security and Consular Affairs (Consular Services and Overseas Voting)
 - 9.2.3 Undersecretary for Multilateral Affairs and International Economic Relations (Economic Diplomacy)
 - 9.2.4 Undersecretary for Migrant Workers Affairs (Assistance to Nationals)
 - 9.2.5 Undersecretary for Bilateral Relations and ASEAN Affairs (National Security)
 - 9.2.6 Undersecretary for Strategic Communications and Research (Public Diplomacy and Cultural Diplomacy)

9.3 The following criteria shall be used to determine the ratings:

9.4 Administrative matters shall be allocated a fixed 15% of the total grade for all Permanent Missions. 85% of the total grade shall be distributed between National Security, Economic Diplomacy, Cultural Diplomacy, ATN, Consular Services, Overseas Voting, and Public Diplomacy. The weights given to the seven areas for each Permanent Mission shall be subject to the approval of the supervising multilateral office and of the PMT.

10. Finalization of Ranking of HDUs and FSPs

- 10.1 The ratings given by supervising offices and the resulting ranking of delivery units shall be presented to the PMT for deliberation, approval, and endorsement to the Secretary of Foreign Affairs.
- 10.2 The Secretary of Foreign Affairs shall have the final decision of the ranking of the Department's delivery units.
