BAC Resolution No. CPM-PB-38-2022

RESOLUTION RECOMMENDING AWARD OF THE CONTRACT ON
PROCUREMENT OF PEST CONTROL AND DISINFECTION SERVICES FOR
JANUARY TO DECEMBER 2022

WHEREAS, the Department of Foreign Affairs, through the authorized appropriations under the FY 2023 National Expenditure Program (NEP), intends to apply the sum of Two Million One Hundred Thousand Pesos (PhP 2,100,000.00) only – the Approved Budget for the Contract (ABC) for the *Procurement of Pest Control and Disinfection Services for January to December 2023*;

WHEREAS, the said Approved Budget for the Contract is chargeable against OCA and OAMSS' 2023 MOOE;

WHEREAS, on 28 October 2022, the Bids and Awards Committee (BAC) conducted a Pre-Procurement Conference to discuss the availability of funds and technical Specifications/Terms of Reference for the Procurement of *Pest Control and Disinfection Services for January to December 2023*;

WHEREAS, on 10 November 2022, the Bids and Awards Committee (BAC) Secretariat posted for seven (7) consecutive calendar days the ***Invitation to Bid*** for the *Procurement of Pest Control and Disinfection Services for January to December 2023* on the DFA and PhilGEPS websites, and at conspicuous places within the premises of the DFA, in accordance with Section 21.2 of the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184;

WHEREAS, on 18 November 2022, the BAC held a ***Pre-Bid Conference***, to discuss the eligibility requirements and the technical and financial components of the contract to be bid, two (2) prospective bidders namely: Mac J Pest Control Services, and Power House Pest Control Services attended the conference;

WHEREAS, on 01 December 2022, the deadline for the submission and receipt of bids as well as the date of opening thereof, only Power House Pest Control Services submitted a bid which the BAC determined to be as follows:

WHEREAS, the BAC declared ***Power House Pest Control Services*** as having the Single Lowest Calculated Bid, and subjected it to Post-Qualification on 06 December 2022, pursuant to Section 34.2 of the IRR of RA 9184, to determine whether it complies with and was responsive to all the requirements and conditions specified in the Bidding Documents;

WHEREAS, during the post-qualification of bids and after careful consideration, the BAC determined that the bid of ***Power House Pest Control Services*** was compliant with and is responsive to all the requirements and conditions specified in the Bidding Documents;

NOW, THEREFORE, we, the members of the Bids and Awards Committee, unanimously RESOLVE to RECOMMEND the award of the *Contract on Pest Control and Disinfection Services for January to December 2023* to ***Power House Pest Control Services*** for having submitted the Single Lowest Calculated and Responsive Bid in the amount of One Million Seven Hundred Two Thousand Two Hundred Seventy-Four Pesos and Seventy-Eight Centavos Only (PhP 1, 702,274.78), pursuant to Section 37 of the revised IRR of RA 9184.

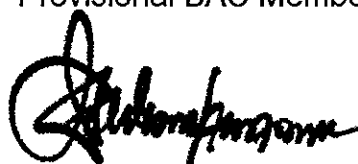

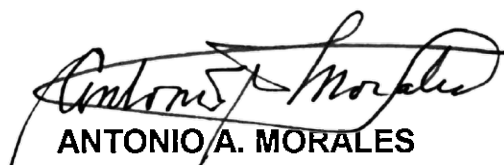
