RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH NEGOTIATED PROCUREMENT UNDER SECTION 53.10 (LEASE OF REAL PROPERTY/VENUE) FOR THE LEASE OF VENUE FOR THE STRATEGIC TRADE MANAGEMENT SUMMIT (STMS)

WHEREAS, the Office United Nations and International Organizations ("UNIO") intends to lease a venue for the Strategic Trade Management Summit ("STMS") on 09 September 2024;

WHEREAS, the lease of venue for the Strategic Trade Management Summit ("STMS") with an Approved Budget for the Contract ("ABC") of *One Million Five Hundred Thousand Pesos* (PhP 1,500,000.00) only, chargeable against UNIO's FY 2024 MOOE for Representation Expenses, is included in the Department's Supplemental Annual Procurement Plan ("SAPP") for FY 2024;

WHEREAS, Sec. 53.10 of the 2016 Revised Implementing Rules and Regulations ("IRR") of Republic Act ("RA") No. 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows Negotiated Procurement as a mode of procurement for the lease of privately owned real property and venue for official use, subject to the Consolidated Guidelines for the Alternative Methods of Procurement of the 2016 Revised IRR of RA 9184;

WHEREAS, in compliance with Item No. (V)(D)(9)(c)(ii)(a), Annex "H" of the IRR, Requests for Quotation ("RFQ") were sent to at least three (3) potential lessors, namely: Shang Global City Properties, Inc. (Shangri-La The Fort Manila); Grand Hyatt Manila; and Ascott Bonifacio Global City;

WHEREAS, in response to the solicitation of offers, a quotation was received from *Shang Global City Properties, Inc.* (*Shangri-La The Fort Manila*), which submitted the single calculated and responsive quotation in the amount of *One Million Two Hundred Thousand Pesos* (PhP 1,200,000.00) only;

NOW, THEREFORE, we, the Members of the Bids and Awards Committee of the Department, RESOLVE to RECOMMEND to the Head of the Procuring Entity ("HoPE") resort to Negotiated Procurement under Section 53.10 (Lease of Real Property/Venue) as the alternative method of procurement for the lease of venue for the Strategic Trade Management Summit ("STMS") from Shang Global City Properties, Inc. (Shangri-La The Fort Manila), subject to the abovementioned requirements, and provided that existing auditing rules and regulations shall be strictly observed by the end-user.
