**RESOLUTION RECOMMENDING AWARD OF THE CONTRACT ON THE
PROCUREMENT OF SECURITY SERVICES FOR THE DEPARTMENT
COVERING THE PERIOD OF EIGHT (8) MONTHS FROM MAY TO DECEMBER
2024**

WHEREAS, the Department of Foreign Affairs (DFA), through the General Appropriations Act FY 2024, intended to apply the sum of Ninety-Five Million One Hundred Forty-Seven Thousand One Hundred Seventy-Five Pesos and 13/100 (Php 95,147,175.13) only being the Approved Budget for the Contract (ABC), chargeable against OAMSS and OCA's FY 2024 Maintenance and Other Operating Expenses (MOOE) under Security Services, for the ***Procurement of Security Services for the Department covering the period of eight (8) months from May to December 2024;***

WHEREAS, on 04 March 2024, the Bids and Awards Committee (BAC) Secretariat conducted a ***Pre-Procurement Conference*** for the aforementioned procurement to ensure that the procurement is in accordance with the Annual Procurement Plan (APP), and to discuss the technical specifications of the project;

WHEREAS, on 15 March 2024, the ***Invitation to Bid*** was posted for seven (7) consecutive calendar days on the DFA website, Modernized PHILGEPS, and conspicuous places within the premises of the DFA, in accordance with Section 21.2 of the Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184;

WHEREAS, on 25 March 2024, the BAC held a ***Pre-Bid Conference*** to discuss the eligibility requirements as well as the technical and financial components of the contract to be bid which was attended by JSL Security Agency, Inc., Commander Security Services, Inc., SM Security and Services, Inc., 1D Security Services, Inc., and NC Lanting Security Specialist Agency;

WHEREAS, on 26 March 2024, a ***Supplemental Bid No. 1*** for the aforementioned procurement was posted for seven (7) consecutive calendar days on the DFA website, Modernized PHILGEPS, and conspicuous places within the premises of the DFA, providing supplemental information for the aforementioned project, in accordance with Section 21.5 of the IRR of RA No. 9184;

WHEREAS, on 08 April 2024, the ***deadline for the submission and receipt of bids*** as well as the date of the ***opening*** thereof, the following bids were received and rated as follows:

WHEREAS, the BAC declared **NC Lanting Security Specialist Agency** as having the single Calculated Bid, and subjected it to **Post-Qualification** on on 12 April 2024, pursuant to Section 34.2 of the IRR of RA 9184, to determine whether it complied with and was responsive to all the requirements and conditions specified in the Bidding Documents;

WHEREAS, during the post-qualification and careful consideration, the BAC determined that the bid of **NC Lanting Security Specialist Agency** was compliant and responsive to all the requirements and conditions specified in the Bidding Documents;

WHEREAS, the Intelligence and Security Unit (ISU), the End-User for this procurement, has likewise confirmed that the bid of **NC Lanting Security Specialist Agency** was compliant and responsive to all the requirements and conditions specified in the Bidding Documents;

NOW, THEREFORE, we, the Members of the Bids and Awards Committee, unanimously RESOLVE to RECOMMEND the award of the Contract on *Security Services for the Department covering the period of eight (8) months from May to December 2024* to **NC Lanting Security Specialist Agency** for having submitted the Single Calculated and Responsive Bid in the amount of **Ninety-Three Million Three Hundred Ninety-Nine Thousand Nine Hundred Ninety-Six Pesos and 31/100 (Php 93,399,996.31)**, pursuant to Section 37 of the revised IRR of RA 9184.
